IMPORTANT NOTICE

Please review your Certificate of Takaful and Certificate Information Statement which you will receive upon successful enrolment of Group Term Takaful plan.

You may cancel your certificate within 15 calendar days from the delivery date of its delivery by giving us written notice. If cancellation occurs during this free look period, any contribution paid will be fully refunded if you cancel the takaful coverage during the free look period.

If you have any queries or change of information, you can call Sun Life Malaysia Takaful Berhad at 1300-88-5055, Monday to Friday from 8.30am to 5.30pm.

Your coverage will start upon issuance of the certificate document. This certificate is renewable up to age 65.

If there is any change in your contribution, at least 90 days written notice in advance will be given to you and the contribution revision will be applicable from the next certificate anniversary after the end of the notice period. As a result of any change of contribution, the wakalah fee and tabarru' will change accordingly.

Your certificate will be renewed on yearly basis with payment deduction from your selected payment option.

If contribution is not paid within the grace period of 31 days, the certificate shall lapse. If a claim is submitted during such grace period, the benefit in respect of such claim shall be payable only if the amount of such benefit is more than the unpaid contribution and the unpaid contribution shall be deducted from the benefit that is payable.

Waiting period of 30 days from the GTT coverage start date (also known as GTT commencement date) is applicable to death and all critical illnesses except for the specified illnesses (angioplasty and other invasive treatments for coronary artery disease, cancer, coronary heart disease requiring surgery, heart attack and serious coronary artery disease) which are subject to the waiting period of 60 days. No benefit would be payable in the event that the person covered died due to natural causes or diagnosed with the critical illness within the waiting period as defined.
